### **Definitions and interpretation**

  - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
  - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. reference to any statutory provision includes any modification or amendment of it;
  - f. the headings and sub-headings do not form part of this privacy policy.

# Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Foam System Services Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Foam System Services Ltd is the "data controller". This means that Foam System Services Ltd determines the purposes for which, and the manner in which, your Data is processed.

# Data collected

- 5. We may collect the following Data, which includes personal Data, from you:

# Data that is given to us by you

- 7. Foam System Services Ltd will collect your Data in a number of ways, for example:

  - b. when you make payments to us, through this Website or otherwise;
  - c. when you elect to receive marketing communications from us;
  - d. when you use our services;

in each case, in accordance with this privacy policy.

# Data that is received from third parties

- 8. Foam System Services Ltd will receive Data about you from the following third parties:
  - a. Generally, Foam System Services Ltd In some cases can receive personal data by third parties (for example a main contractor, another industry contractor, or consultant.

### Data that is received from publicly available third parties sources

- 9. We will receive Data about you from the following publicly available third party sources:
  - a. Names, addresses, telephone numbers, e-mail addresses and other contact details.
    b. Car details (about those who use our vehicles or parking facilities).
    c. Past, present and prospective staff academic, disciplinary, and attendance records (including information about any special needs), and training and examination scripts and marks.
    d. Where appropriate, information about individuals' health

### Data that is collected automatically

- 10. To the extent that you access the Website, we will collect your Data automatically, for example:
  - a. we automatically collect some information about your visit to the Website. ### Who we share Data with

- 13. We may share your Data with the following groups of people for the following reasons:
  - a. our employees, agents and/or professional advisors Occasionally, Foam System Services Ltd will need to share personal information with third parties, such as professional advisers (lawyers, insurers and accountants);
  - b. relevant authorities to facilitate the detection of crime or the collection of taxes or duties; in each case, in accordance with this privacy policy.

  - b. we store your Data on secure servers.

### Your rights

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
  - b. Right to correct the right to have your Data rectified if it is inaccurate or incomplete.
  - c. Right to erase the right to request that we delete or remove your Data from our systems.
  - d. Right to restrict our use of your Data the right to "block" us from using your Data or limit the way in which we can use it.
  - e. Right to data portability the right to request that we move, copy or transfer your Data.
  - f. Right to object the right to object to our use of your Data including where we use it for our legitimate interests.

- 39. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
